This is a general privacy policy for purpose of TESTING the application and website before going life

This privacy policy ("*Privacy Policy*") governs data collection and usage of the services, software, platform, and websites provided by Thepetsociety.app ("Thepetsociety.app," "we," "us," or "our") and any of its affiliates (collectively, the "*Services*"). This Privacy Policy is intended to meet requirements globally, including those in North America, Europe, APAC, and other jurisdictions. Your rights

Right to access

As a data subject you have the right to obtain from us free information about your personal data processed at any time and a copy of this information. Furthermore, you will have access to the following information: the purposes of the processing; the categories of personal data concerned; where possible, the envisaged period for which the personal data will be processed, or, if not possible, the criteria used to determine that period; the existence of the right to request from us rectification or erasure of personal data, or restriction of processing of personal data concerning you, or to object to such processing; the existence of the right to lodge a complaint with a supervisory authority; where the personal data are not collected directly from you, any available information as to their source; and the existence of automated decision-making, including

profiling, and, at least in those cases, meaningful information about the logic involved, as well as the significance and envisaged consequences of such processing for you.

Right to rectification

You have the right to obtain from us, without undue delay, the rectification of inaccurate personal data concerning you. Taking into account the purposes of the processing, you shall have the right to have incomplete personal data completed, including by means of providing a supplementary statement.

Right to be forgotten

You have the right to obtain from us the erasure of personal data concerning you as soon as possible, and we shall have the obligation to erase personal data without undue delay where required by the law, including when:

the personal data is no longer necessary in relation to the purposes for which they were collected or otherwise processed;

there is no longer a legal ground for the processing;

you object to the processing and there are no overriding legitimate grounds for the processing;

the personal data has been unlawfully processed;

the personal data must be erased for compliance with a legal obligation in accordance with the applicable law to which we are subject.

Right to restriction of processing

You have the right to obtain from Thepetsociety.app restriction of processing where one of the following applies:

the accuracy of the personal data is contested by you, for a period enabling us to verify the accuracy of the personal data;

the processing is unlawful and you oppose the erasure of the personal data and requests instead the restriction of their use instead:

we no longer needs the personal data for the purposes of the processing, but they are required by you for the establishment, exercise or defense of legal claims; and/or you have objected to processing pursuant to applicable laws.

Right to object

You have the right to object, on grounds relating to your particular situation, at any time, to the processing of personal data concerning you. We shall no longer process the personal data in the

event of the objection, unless we can demonstrate reasonable grounds for the processing, which override the interests, rights and freedoms of you, or for the establishment, exercise or defense of legal claims.

Right to withdraw data protection consent

You have the right to withdraw your consent to the processing of your personal data at any time.

International transfers

We are entitled to transfer your personal data to third parties abroad for the purposes of data processing.

As personal data processors, they are obliged to protect data privacy to the same extent as we ourselves. We choose the processors carefully to ensure compliance with applicable laws.

Data security

We use appropriate technical and organizational security measures to protect your personal data. Our security measures are continuously improved in line with technical developments.

Duration of data processing

We will process your personal data only for the period necessary to achieve the purpose of the processing, or as required by applicable laws. After the period the personal data will be deleted.
